Sub: Issue of Essentiality Certificate under Rule 44 to start a new un-aided school.

Sir,


With refereme to your application on the subject noted above, I am directed to convey the permission of the Director of Education,Delhi to your Society to start a new school in District North in Ashok Vihar area from class I to VIII subject to the following terms and conditions:

1. That the provision of Delhi School Education Act,1973 and rules framed thereunder shall be observed by the society.
2. That the management of the school will fulfil all the conditions laid down under rule 50 and provide all the facilities given in rules 51 of Delhi School Education Act, 1973 to the institution.
3. That the management of the school will get the scheme of management approved from the Department immediately.
4. That only qualified and trained teachers will be appointed and prescribed Govt. scales alongwith all allowances will be paid to the teachers and non-teaching staff through crossed cheques.
5. That the management of the school will not ask for grant-in aid from the Department.
6. That the school will not run for the profit of any individual association or a group of persons.
7. That in case at any time the management of the school is unable to run the school, moveable and non-moveable property of the school will be transferred in the name Director of Education,Delhi.
8. That the management of the school will apply for grant of recognition of the school under the D.S.E.A.1973, separately and recognition will not be granted unless such statutory provision of Section 4(1)(a to f) read with rules 50 and 51 are fulfilled.
9. That all the recognised classes shall be run at one place.
10. That the management of the school will obtained land from DDA in the name of the society for the proposed school through Directorate of Education,Delhi.

11. That the proposed school will be run under the banner of Aggarwal Welfare Society and suitable funds for the purchase of land as well as construction of suitable building thereon as per the specification of the Department will be made available. The proposed school may be started only after the allotment of land within a period of three years from the date of issue of this Essentiality Certificate and adequate and sufficient accommodation for class rooms. The normal size of classrooms shall be in 24'x 20'.

If recognition of the proposed school is not sought after fulfilling the above conditions within a period of three years of this permission to open a new school shall be treated as cancelled.
